

## Revised Golden Ticket Raffle Terms and Conditions

Philos Hospitality - Hospitality House of Tulsa Gala 2025 Confidentiality Notice: The information, comments, and conclusions in these Rules apply only to the Golden Ticket Raffle and are for the exclusive use of Philos Hospitality - Hospitality House of Tulsa. No third parties are authorized to rely on this document for any purpose.

These official rules (the “Rules”) govern the Golden Ticket Raffle (“Raffle”) benefiting Philos Hospitality - Hospitality House of Tulsa, a 501(c)(3) non-profit charitable organization dedicated to providing supportive housing and services for individuals and families in need in the Tulsa community. The Raffle is conducted pursuant to Oklahoma law, specifically in compliance with Oklahoma Statutes Title 21, Chapter 68, and the April 2024 Oklahoma Attorney General opinion permitting online raffles by qualified nonprofits, and is subject to all applicable federal, state, and local laws. Void where prohibited by law.

### Eligibility

The Raffle is open to legal residents of the fifty (50) United States and the District of Columbia who are at least 19 years of age at the time of entry, in accordance with Oklahoma gaming laws. Employees of Philos Hospitality - Hospitality House of Tulsa and their immediate families (spouses, siblings, parents, children, and household members) are not eligible to participate. Entrants are not required to be physically located in Oklahoma at the time of ticket purchase, and winners are not required to reside in or be present in Oklahoma.

### How to Enter

Raffle tickets (“Tickets”) are physical tickets, numbered and held securely in a locked box at the offices of Philos Hospitality - Hospitality House of Tulsa. Tickets can be purchased online at [\[www.philoshospitality.org/raffle\]](http://www.philoshospitality.org/raffle), managed exclusively by employees of Philos Hospitality - Hospitality House of Tulsa, as part of their regular duties. Tickets will be available beginning September 8, 2025, at 12:00 PM CDT, until all 100 tickets are sold. Tickets are considered sold in Tulsa, Oklahoma, Tulsa County, Oklahoma, upon receipt of full payment. Each Ticket will bear the name “Philos Hospitality - Hospitality House of Tulsa” and its 501(c)(3) tax-exempt status, state that it is non-transferable, and note that the purchase price is not a deductible charitable contribution.

- Ticket price: \$100 each.
- A maximum of 100 tickets will be sold.
- All ticket purchases are final and non-refundable, except that if fewer than 50 tickets are sold by the date all tickets are sold or the Raffle is terminated, purchasers may choose a full refund or a tax-deductible contribution to Philos Hospitality.

By purchasing a ticket, each participant (“Entrant”) agrees to be bound by these Rules and affirms compliance with the eligibility requirements set by Philos Hospitality. Drawing

The Raffle will end when all 100 tickets are sold. Philos Hospitality - Hospitality House of Tulsa, at its sole discretion and in compliance with Oklahoma law and the April 2024 Attorney General opinion, may extend the Raffle or terminate it early if necessary, with updates posted on [\[www.philoshospitality.org/raffle\]](http://www.philoshospitality.org/raffle). A random drawing will be conducted within 7 days of all 100 tickets

being sold, using a manual selection process from the locked box in the presence of at least two authorized witnesses, documented by Philos Hospitality. Philos Hospitality will provide the winner's information to HGA Fundraising, who will notify the Potential Winner within 7 days via their chosen method (e.g., email or phone) at the contact information provided during purchase. The winner must accept the Prize within 30 days of notification or forfeit it. The fair market value of the Prize, documented as \$2,295, will be provided to the winner. The decision of Philos Hospitality is final and binding under Oklahoma law.

#### Prize

The Prize is a travel voucher issued by Philos Hospitality - Hospitality House of Tulsa, facilitated through HGA Fundraising, having a fair market value of \$2,295, offering a choice of traveling to any of the following destinations:

- Cabo, Mexico
- Tuscany, Italy (with wine delivery)
- Sedona, Arizona
- Kentucky Bourbon Experience

The voucher is subject to availability, expires 24 months from the purchase date (e.g., September 8, 2027, if purchased September 8, 2025), and may be used for a travel package of the Winner's choosing. Transportation to the location, airport transfers, resort fees, and upgrades are not included. A valid passport is required for international travel (Cabo, Tuscany). Travel during holidays or peak periods is subject to availability and may incur extra costs. The voucher may not be resold or donated and is non-refundable. The Winner assumes all responsibility for taxes, fees, or expenses related to the Prize. All appropriate IRS and Oklahoma Tax Commission forms will be provided, and withholding may apply as required by law.

#### Odds

Odds of winning depend on the total number of tickets sold, up to a maximum of 100, and are not disclosed.

#### Publicity

By participating, Entrants grant Philos Hospitality - Hospitality House of Tulsa a worldwide, perpetual, royalty-free license to use their name, likeness, or image for promotional purposes without further compensation, except where prohibited by Oklahoma law.

#### Release and Indemnification

Entrants release Philos Hospitality - Hospitality House of Tulsa, its affiliates, directors, officers, agents, and volunteers (collectively, the "Released Parties") from any and all claims, damages, liabilities, or causes of action arising from participation in the Raffle, Prize acceptance, use, or related activities, including but not limited to personal injury, property damage, or tax obligations, whether caused by negligence or otherwise. Entrants agree to indemnify and hold harmless the Released Parties against

any claims, demands, or losses resulting from their participation or Prize use, to the fullest extent permitted by Oklahoma law.

#### Taxes and Deductibility

Ticket purchases are not a deductible charitable contribution under IRS guidelines for raffles. The Winner will receive an IRS Form W-2G for the Prize value of \$2,295, with federal withholding applied only if required by law (e.g., if total winnings exceed thresholds beyond this raffle). Philos Hospitality will file a scannable Copy A of Form W-2G with the IRS (using official forms ordered from IRS.gov/EmployerForms) and provide Copy B to the Winner. If 10 or more information returns are issued, e-filing is required via IRS.gov/InfoReturn; otherwise, paper filing with official forms is permitted. A Form 1099-MISC will also be provided to the Winner. Consult a tax advisor. Philos Hospitality will comply with all IRS and Oklahoma Tax Commission reporting and withholding obligations.

#### Delivery and Conditions

The Prize will be coordinated with the Winner for travel arrangements via the redeemable voucher. All risk of loss passes to the Winner upon issuance of the voucher. The Prize is awarded “as is,” with no express or implied warranties beyond what is stated, and Philos Hospitality disclaims liability for travel disruptions or issues beyond its reasonable control.

#### Disputes and Governing Law

The Raffle is governed by the laws of the State of Oklahoma. Notwithstanding any applicable statutes relating to conflicts of law, only Oklahoma law shall govern all aspects of the conduct of, and performance in connection with, the Raffle. Any claims or disputes must be brought in the District Court of Tulsa County, Oklahoma, and Entrants consent to the personal jurisdiction of such courts. Disputes will be resolved individually, without resort to class action, and damages shall be limited to actual out-of-pocket costs associated with ticket purchase, excluding attorneys’ fees, punitive, incidental, consequential, or multiplied damages, as permitted under Oklahoma law. The decisions of Philos Hospitality concerning all matters relating to the Raffle shall be final and binding.

#### General

Philos Hospitality - Hospitality House of Tulsa reserves the right to modify these Rules to comply with Oklahoma law, federal regulations, or the April 2024 Attorney General opinion, with updates posted on [\[www.philoshospitality.org/raffle\]](http://www.philoshospitality.org/raffle). If the Prize becomes unavailable due to unforeseen circumstances, Philos Hospitality may substitute a cash equivalent of equal value or reschedule the drawing, subject to approval by the Oklahoma Secretary of State if required. All proceeds from the Raffle will benefit Philos Hospitality’s charitable mission and will not inure to private shareholders. All decisions are final and binding.
